## II. Chairman Welcome and Remarks-Danny Seiden, President & CEO, Arizona Chamber of Commerce & Industry

Sarah Forlano, Executive Assistant, Arizona Chamber of Commerce & Industry represented Danny Seiden, welcomed members, and discussed Manufacturing Month. Arizona's manufacturing momentum is evident in the data as well. Consider these facts:

- Arizona has added 14,100 jobs in manufacturing over the year, a growth rate of 7.8%, more than double the U.S. rate of 3.7%.
- Between 2015 and 2021, Arizona's manufacturing share of Real GDP, a measure of economic output, grew from \$25.2 billion to \$32.8 billion for a rate of 30.4% more than double the U.S. manufacturing growth rate (14%).
- With more than 285 projects in our pipeline, manufacturing represents 67% of projects, 84% of jobs, and 92% of capital expenditures.
