II. Welcome Remarks from Chair Governor Doug Ducey

Governor Ducey welcomed the Board members and thanked them for their service. He discussed the outstanding results of the trade mission he had recently led to Israel. He highlighted his meetings with Israel Prime Minister Benjamin Netanyahu and former president Shimon Peres on cybersecurity and the Iron Dome, as well as his speaking engagement at WATEC, one of the premier global dialogues and exposition focused on innovation for the world's water and ecologic system. Governor Ducey also discussed how the launch of the statewide branding initiative, the publication of the AZ Awesome newsletter, which celebrates the good news and achievements in our great state, the ACA's clean audit, Aviage System's celebration of their grand opening in Peoria and the Governor's proclamation of October as Manufacturing month.
