II. Approval of Minutes of November 20, 2013*

Bill Assenmacher moved to approve the minutes of the November 20, 2013 Rural Business Development Advisory Council Public Meeting; Les Orchekowsky seconded. The motion was approved.

III. Arizona Innovation Challenge

Randy Gustafson, ACA Vice President of Innovation, highlighted four programs the Arizona Commerce Authority offers that can assist start-up businesses: Small Business Capital Investment Tax Credit (Angel Investment), PIII Playbook, AZ Fast Grant, and Arizona Innovation Challenge. Provided to the council members were data sheets that detailed the incentives, while a general overview of each was given. Angela Harmon and Leroy Shingoitewa, Committee Members, promoted a discussion on how council members can effectively assist rural communities to utilize these tools for economic growth.

IV. SciTech Festival Presentation

Jeremy Babendure, ACA Executive Director of AZ SciTech Festival, described the festival as a strategy not an event. It is a celebration of science and technology to act as a tool in promoting community identity and economic development. It is a way for Arizona to showcase its assets and create an initiative through local communities to highlight that STEM is in everything. Julie Pastrick, Chair, challenged the members to critically think how the SciTech Festival can benefit their communities and to enhance the view of STEM.

V. ACA Activity Update

Keith Watkins, Committee Member, reported on the Council term amendments including process to extend terms and the latest appointed member-Ron Gould of Mohave County; detailed the parameters for our next Council meeting which will include a Strategic Futures Focus Group; updated the Council on the first round of Rural Grant Applications; and detailed the benefits and parameters of the Economic Development Academies.

VI. Call to Council Members for Future Agenda Items

Bill Assenmacher, Committee Member, suggested that the members critically think about the increasing divide between rural and urban communities and

how they, as economic development leaders, will create efforts to limit that gap. Stephen Rutherford, Committee Member, suggested that the community leaders create a platform to list all resources for rural businesses to inform them of the resources available to their area.
