II. Approval of Minutes of July 30, 2014*

David Bentler moved to approve the minutes of the September 24, 2014 Rural Business Development Advisory Council Public Meeting; D.L. Wilson seconded. The motion was approved.

III. Presentations

a. Expect More Arizona— Pearl Chang Esau

Pearl Chang Esau, Expect More Arizona, gave the board a background of what Expect More Arizona is and she discussed engaging community support in regards to education. She highlighted that changes in children's education start in the home.

b. Congressman Paul Gosar's Office—Stephen Briggs

Stephen Briggs, gave the council a brief update on what is happening in Congress. Discussed were many issues specific to Rural Arizona. Those include, energy and public lands issues, Southeast Arizona Land Exchange Act, PILT and increasing public access.

c. Grand Canyon Trust - Natasha Hale

Natasha Hale, gave the council a brief background on the mission of the Grand Canyon Trust. She also discussed the ability for Tribes to apply and receive grants from the ACA. Keith Watkins, ACA, noted that the Tribes qualify for the REDG grant.

d. SBIR Program — Jill HowardAllen,

Jill HowardAllen presented what SBIR/STTR grants are and who are eligible to receive them. She stated that these are not just research grants but also a focus on commercialization. She highlighted the recent SBIR training in Sierra Vista and informed board members that if they would like a training in their area to contact her.

e. Small Business Services — Kathy Rodriguez*

Kathy Rodriguez, presented all of the work that the Small Business Services Office at the ACA does. Her presentation included a copy of Arizona Entrepreneur's Edge for all board members. This handbook is a resource guide for not only entrepreneurs but community leaders. The handbook highlights business assistance and counseling, financial options and funding sources, business structures and registration and business licensing and tax information, among other items.

IV. ACA Update Discussion—Keith Watkins

Keith Watkins, updated the Council on the ACA's activity. Keith also updated the committee on the recent announcement of the bankruptcy of GT Advanced Technologies and what the implications may be.
