- If your answer is 'No', you are not eligible to receive a Certificate of Free Sale from the State of Arizona.
- 2. Please provide us with 3 invoices/bills of lading for each product to be included on the Certificate of Free Sale to prove that the products are freely traded within the U.S. Invoices must be dated within 3 months prior to the application date one of the invoices must be from an Arizona buyer, and the other two can be from anywhere within the U.S. All must contain customer names, addresses, and phone numbers.
- 3. Listing the Products on the Application:
  - Products sold abroad under a different name than in the U.S. must be listed using the U.S. name.
  - The Certificate will only be issued in English language.
- 4. There is no longer a fee/cost associated with the Certificate of Free Sale from the State of Arizona. Certificates expire one year from the date issued. The above 3 steps must be followed to renew a Certificate.
- 5. Reprints or Copies of Certificate of Free Sale
  - Reprints or copies of newly/previously-issued certificates are available by request within one year of the
    original date of issuance.
  - To receive a reprint/copy, submit a copy of the Certificate that was issued or request the number needed on the original application.
- 6. Certificates of Free Sale for Non-Consumable items are issued by the Arizona Commerce Authority. Send your completed application form and copies of three separate invoices as described above per product to:
