



### **Small Business Lottery Arizona Job Training Program (the “Program”)**

The Arizona Commerce Authority (the “ACA”) received a total of 58 “Election to Participate” forms from businesses seeking to participate in the Small Business Lottery drawing. Each form was timely submitted on or before 11:59 p.m. on Monday, August 11, 2014. Following its submittal, one company withdrew its form. Thus, a total of 57 small businesses were ultimately considered in the Small Business Lottery drawing.

In accordance with Section 5 of the Program Rules, the Small Business Lottery drawing was held on August 27, 2014 at 2:00 p.m. to determine the order in which Program incumbent grant awards for Small Businesses will be made. The ACA’s Financial Incentives Program Division coordinated the lottery and, pursuant to the Program Rules, ACA staff handpicked lottery tickets from an opaque container.
