At its discretion, the Authority may consider and act upon any agenda item out of order. One or more Board Members may participate via teleconference. If authorized by a majority vote of the Board attending the meeting, an executive session will be held immediately following the vote in accordance with A.R.S. § 38-431.03(A)(1), (3) and/or (5) and the meeting will be temporarily recessed while the Board retires to executive session, which will not be open to the public.
