## II. Welcome Remarks from Chair-Governor Doug Ducey

Governor Doug Ducey, Chair, opened the meeting by stating that Arizona's economy is booming. There are 160K new private sector jobs since 2015 with 200K new residents. Arizona is a Top 5 State for Economic Momentum and among the Top 5 States for GDP growth at a rate of 3.2% during 2017. Arizona job growth in 2017 also outpaced the national average at 2.4%



and is expected to continue to do so over the next year at a rate of 2.5%. The unemployment rate is at its lowest in a decade and the good news just keeps coming.

Governor Ducey also discussed significant new investments in education, including his plan to provide teachers with a 20% raise by school year 2020 was just passed. Funding to restore cuts made during the recession with \$100M additional flexible dollars for schools this year was also passed. Many districts have already committed to these raises and more, including raises for support staff. The state is investing millions more in our public schools and state universities.

The Governor also discussed continuing leadership in innovation. Most recently, in March, he signed legislation making Arizona the first state in the country to create a sandbox program for the testing of innovative new financial technology – or "fintech" products. Financial services companies around the world--from industry giants to startups--now have their eyes on Arizona as the place to test, launch and scale their next big idea.

## IV. CEO Report-Sandra Watson (A.R.S. § 38-431.02(K))

President and CEO, Sandra Watson, announced that the ACA has once again had a record breaking year: 87 projects, 25,978 jobs, \$58,304 average wage, \$3.8 billion capex. Trends in HQ operations, which create high wage exec level jobs and often attract companies in the supply chain.

President and CEO, Sandra Watson, welcomed five of the ACA's FY 2018 client companies in attendance at the meeting.

Sandra Watson then introduced Kevin Sullivan, SVP Business Attraction & Expansion who showcased current client activity within the business attraction and expansion pipelines for Q4 FY 2018; highlighting California. Kevin noted an increase in bioscience projects due to three large deals and noted large data center projects are contributing to increased capital investment.
