# **ABOUT THIS REPORT**

This report was created to assist Arizona Local Workforce Development Areas in completing their 2020-2024 Local Workforce Development Plans. The report summarizes key demographic, labor market, and workforce trends occurring within the state and local economy. The information provided in this report is intended to be a resource for local workforce information board members and workforce practitioners during the local workforce planning process.

# ABOUT THE ARIZONA OFFICE OF ECONOMIC OPPORTUNITY

The Office of Economic Opportunity (OEO) was created to strengthen the analytical capabilities of the state's workforce and economic development initiatives. OEO serves as Arizona's workforce planning coordinator, and in this role, provides operational, strategic and research support to the Workforce Arizona Council and other key workforce partners. OEO produces official statewide data for population, employment, and wage estimates including the official Arizona employment and population projections. OEO also functions in an advisory capacity by providing economic expertise to state and local government agencies and officials.

# **OVERVIEW**

The economy in Santa Cruz includes of a wide range of industries offering opportunities for individuals seeking employment of all types.

Positive economic and workforce trends were recorded in Santa Cruz County include:

- Labor force participation grew in 2018, increasing by 231 people, or 1.2 percent from 2017.
- In 2018, six out of seven major industry sectors in Santa Cruz recorded positive year-over-year employment growth.
- Manufacturing grew by 7.2 percent, and Other Services, which grew by 4.3 percent led employment gains in 2018.
- Santa Cruz's total employment is projected to increase by 0.3 percent annually from Q3 2018 through Q2 2020.
- Santa Cruz's population is expected to grow from 2019 to 2022.

Other less-favorable economic and workforce trends recorded in Santa Cruz County include:

- An unemployment rate higher than the statewide and national rates.
- A below-average percentage of residents with a bachelor's degree or higher (22.1 percent) compared to Arizona (28.4 percent).
- In 2018, one of the seven major industry sectors (Construction) in Santa Cruz County reported a year-over-year employment decline.
- From 2013 to 2018, population continued to decline.

Changes in population can have a large impact on a local economy. An area experiencing population growth, particularly growth in working-age populations, may experience an increase in economic development activity<sup>1</sup> and workforce diversity.

- Arizona had one of the fastest growing populations in the U.S. from 2013-2017, ranking 9<sup>th</sup> among all U.S. states.
- From 2013 to 2018, the population in Santa Cruz decreased 480 people, or -0.2 percent.
- From 2017 to 2018, Santa Cruz's population decreased by 125 people, or -0.3 percent.

Population projections provide useful insight into an area's future demand for resources and services.<sup>2</sup> An area experiencing population declines may choose to focus efforts on filling current job positions, while an area experiencing population growth may choose to focus on job creation. Further analysis into the composition of growing or declining populations can be a useful next step.

- Arizona is projected to add 406,032 people to its population from 2019-2022, growing by an annualized rate of 1.0 percent.
- From 2019 to 2022, 53 percent of population is projected to come from natural change, with the remaining 48 percent coming from migration into the county.
- 26 percent of Santa Cruz's population growth from 2019 to 2022 is projected to come from foreign migration, likely due to its proximity to the border.

It is important to understand the employment barriers faced by those served when developing workforce strategies. Population characteristics can help illuminate vulnerable segments of an area's population. An

area with population characteristics that are significantly different than state or national averages, may need to consider specific approaches on how best to meet the needs of their unique population.

- Median household income in Santa Cruz County was dramatically lower than in Arizona. However, median family grew in 2018, increasing to \$40,467 from \$39,630 in 2017.
- The labor force participation rate was lower in Santa Cruz County when compared with the United States and Arizona.
- In Santa Cruz, the percentage of families in poverty was twice as large as the United States rate.

- Santa Cruz County used public assistance programs at a substantially higher rate when compared with the state.
- When compared with the state and the nation, Santa Cruz County used SNAP and AHCCCS at dramatically higher rates.


Understanding the current educational attainment of your local area's available workforce is a crucial step in identifying job seeker and business needs. Education is an important element in determining job

success, and, oftentimes, can lead to higher-paying jobs and lower rates of unemployment.<sup>3</sup>

- 75.6 percent of all Santa Cruz residents are at least high school graduates, lower than the statewide rate of 86.8 percent.
- From 2017 to 2018, the percentage of residents in Santa Cruz with less than a high school education decreased from 24.6 percent to 24.3 percent.

# WORKFORCE

## Unemployment Rate Comparisons, Sept. 2009-Sept. 2019, Not-Seasonally Adjusted



- For the past ten years, Santa's Cruz's unemployment rate has been nearly double the statewide unemployment.
- In 2018, there was an average of 1,803 unemployed individuals in Santa Cruz County.
- From 2017 to 2018, labor force levels increased 231 people, or 1.2 percent.

## Unemployment Rate by Educational Attainment, 2018, Ages 25-64




Historically, higher educational attainment levels lead to lower levels of unemployment.<sup>4</sup> Understanding the relationship between unemployment and education can help determine which education levels are most in need of targeted workforce efforts.

• Unemployment rates for those with a high school diploma or less were substantially higher in Santa Cruz County when compared with Arizona.

- Total nonfarm employment decreased by 300 jobs from 2009 to 2018, an annualized decrease of 0.2 percent over this nine-year period. Over this same period, Arizona average total nonfarm employment increased by 1.8 percent annually.
- Santa Cruz County's job growth has fluctuated since the recession, but has generally remained below, or slightly above zero percent growth.

Office of Economic Opportunity

- From 2013 to 2018 in Santa Cruz County, four out of seven industries recorded positive employment growth.
- In Santa Cruz, employment growth was led by Trade, Transportation, and Utilities, which grew annually by 18.3 percent or 3,169 jobs.

- In Santa Cruz County, Other Services is projected to record the largest annual growth rate at 2.2 percent.
- In 2020, Trade, Transportation, and Utilities is projected to be the industry that employs the most people.
- In Santa Cruz County, Professional and Business Services is the industry projected to have the greatest numeric growth.
