Nonfarm Employment Increased by 30,200 Jobs over the Month in September 2020 Arizona Unemployment Rate Increased to 6.7%

The Arizona seasonally-adjusted unemployment rate increased to 6.7% in September from 5.9% in August. The U.S. seasonally-adjusted unemployment rate decreased to 7.9% in September from 8.4% in August. Over the month, Arizona's seasonally-adjusted labor force increased by 151,727 individuals or 4.4%. Over the year, labor force levels decreased by 19,567 individuals or 0.5%.

Over the Month

Arizona nonfarm employment increased by 30,200 jobs or 1.1% in September. Historically (2010-2019), nonfarm employment has averaged a gain of 28,700 jobs in September.

The Government sector recorded a gain of 10,800 jobs in September. The private sector recorded a gain of 19,400 jobs in September. Historically (2010-2019), private sector employment has averaged a gain of 5,500 jobs in September.

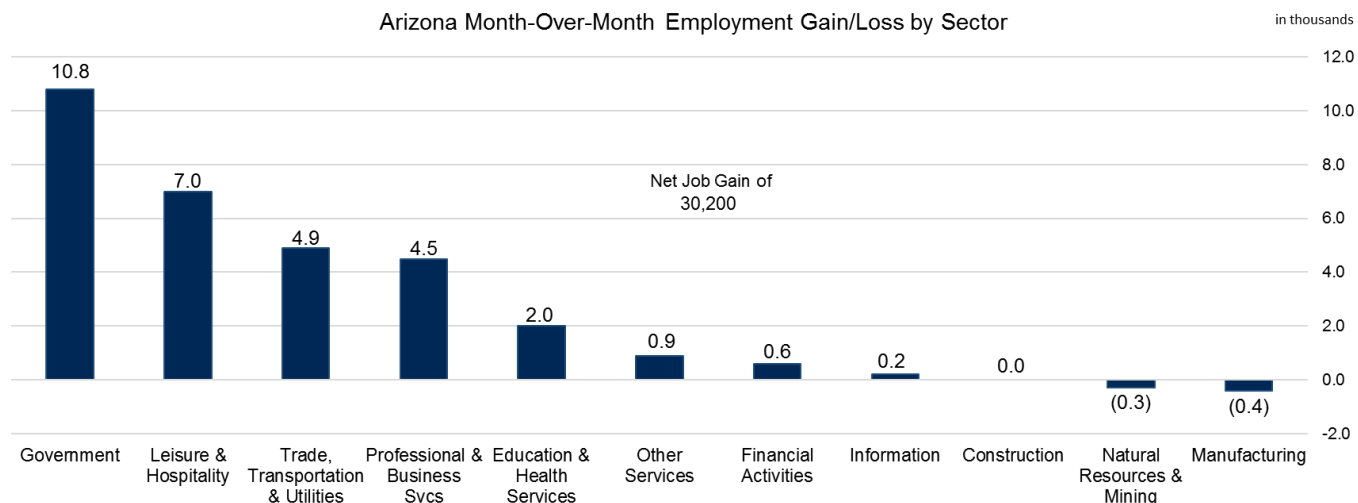

Over the Year

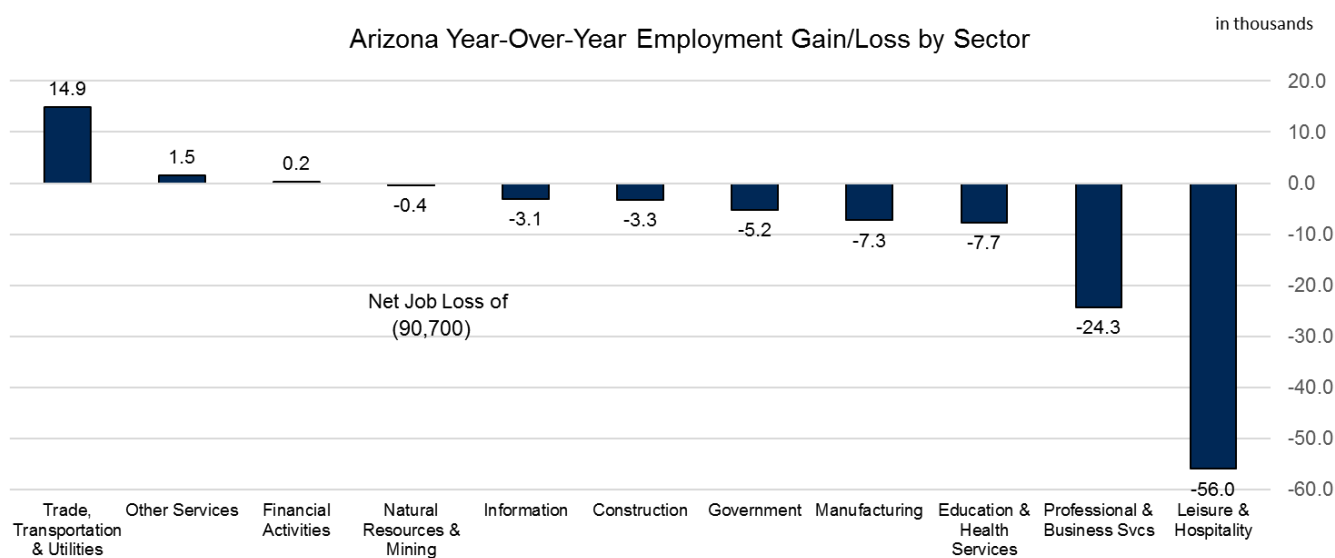
Arizona nonfarm employment decreased by 90,700 jobs or -3.1% in September. A majority of the losses were recorded in private sector employment (-85,500 jobs), while Government recorded losses of 5,200 jobs in September.

Losses were reported in:

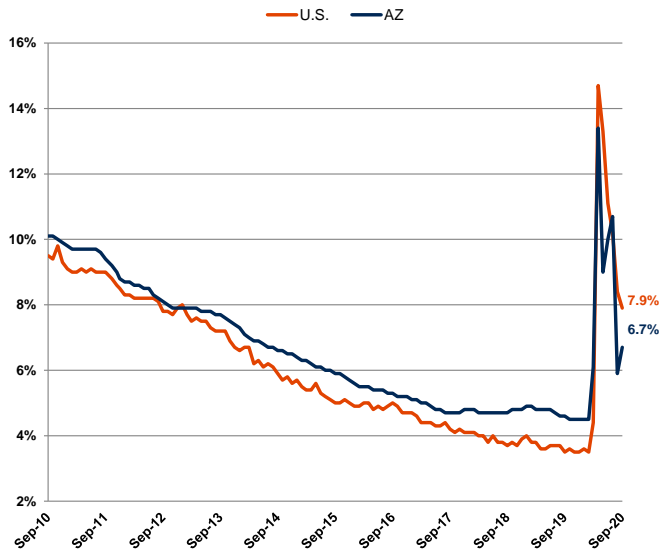

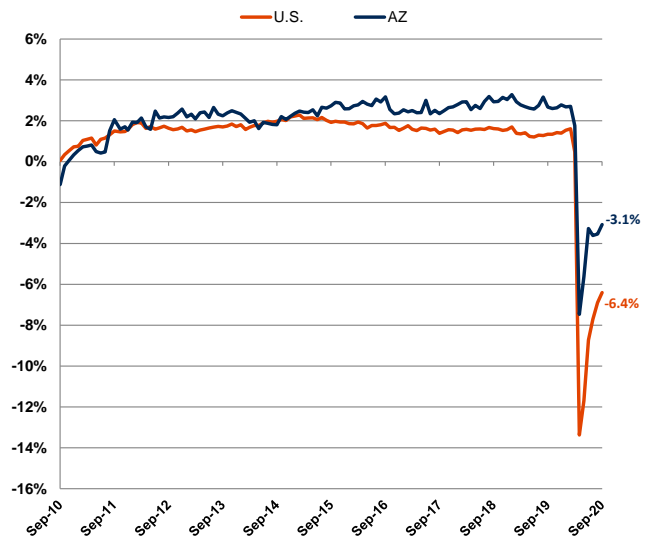

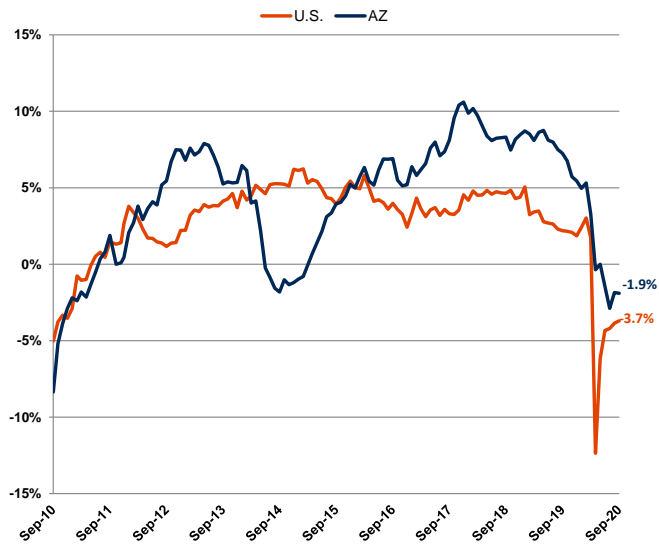
Arizona & U.S. Unemployment Rate
Seasonally Adjusted



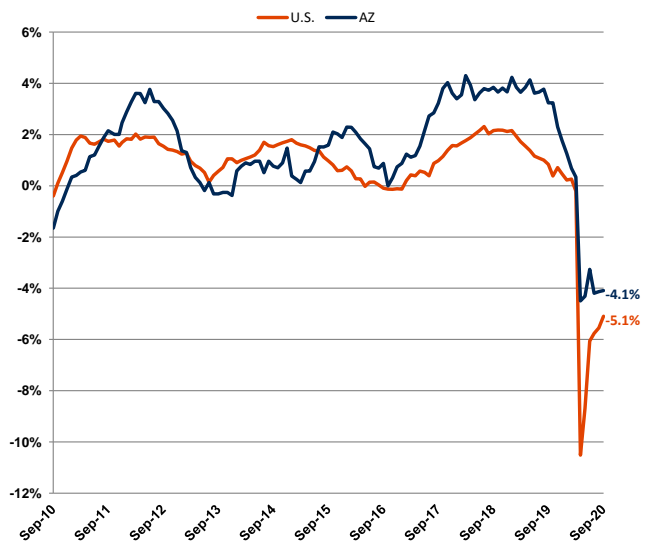
Arizona & U.S. Nonfarm Employment

Year-to-Year Percent Change



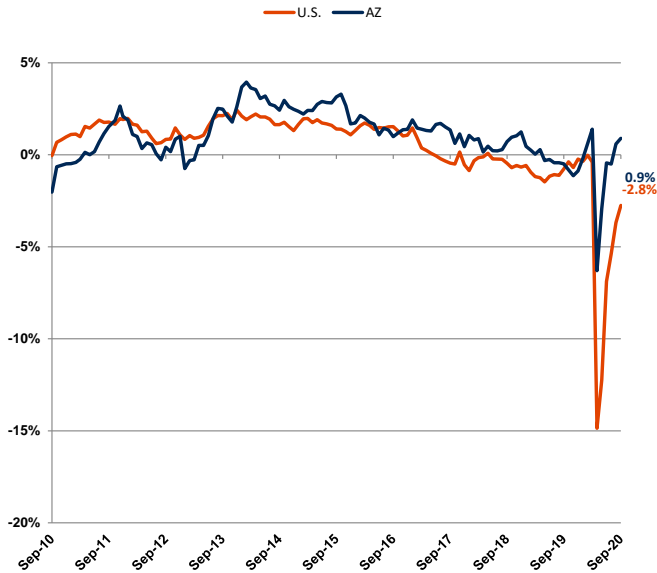
Arizona & U.S. Manufacturing Employment
Year-to-Year Percent Change



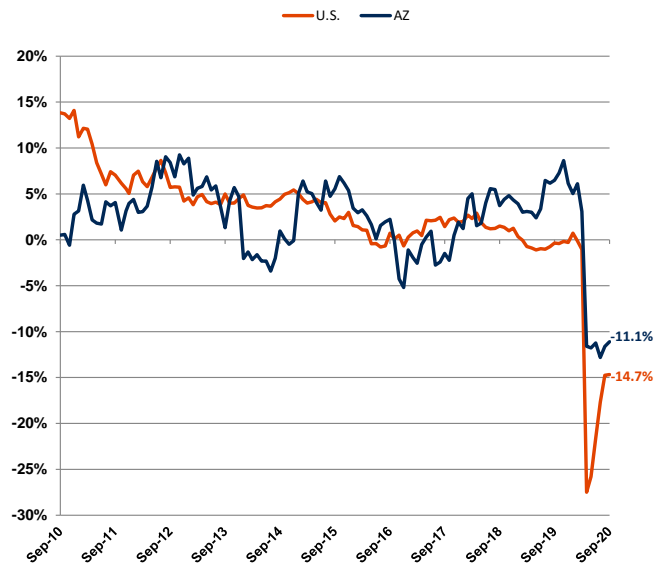

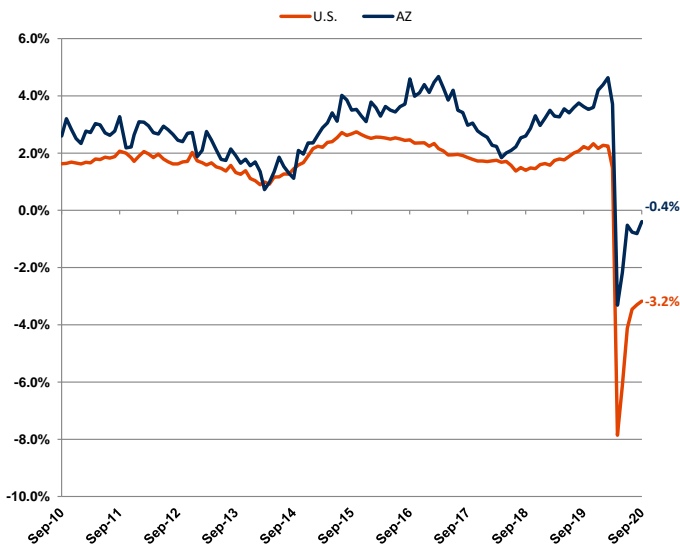
Arizona & U.S. Retail Trade
Year-to-Year Percent Change



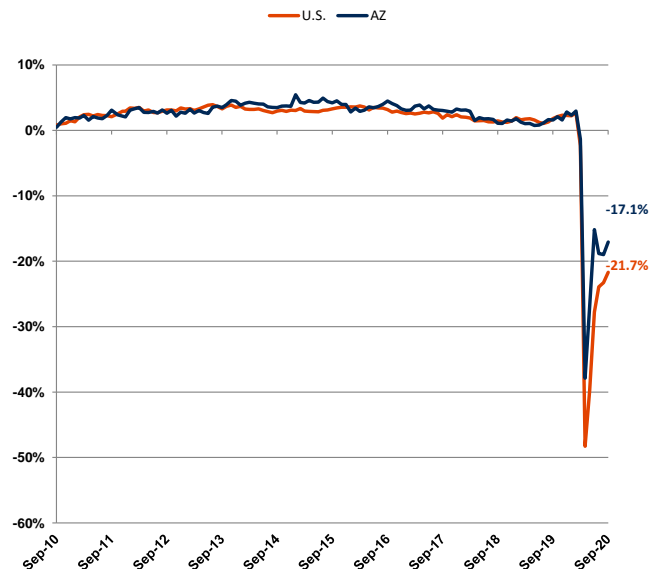
Arizona & U.S. Employment Services
