Total Nonfarm Employment Increased by 93,700 Jobs Year Over Year in December 2022 Arizona Unemployment decreased to 4.0%

The Arizona seasonally adjusted (SA) unemployment rate decreased to 4.0% in December 2022 from 4.1% in November 2022. The U.S. SA unemployment rate decreased to 3.5% in December 2022 from 3.6% in November 2022.

Month over month, Arizona's SA labor force increased by 7,826 individuals, or 0.2%. Year over year, the SA labor force increased by 99,816 individuals, or 2.8%.

Month over month, Arizona not-seasonally adjusted (NSA) total nonfarm employment increased by 400 jobs¹. Year over year, NSA total nonfarm employment increased by 93,700 jobs, or 3.1%. Arizona SA total nonfarm employment increased by 3,100 individuals, or 0.1%, month over month.

Month Over Month

Arizona NSA nonfarm employment increased by 400 jobs in December. Prior to the pandemic (2010-2019), NSA nonfarm employment gained 5,600 jobs on average in December. The government sector² recorded a loss of 10,800 jobs in December, more than the pre-pandemic (2010-2019) average loss of 4,100 jobs. Employment losses in the government sector occurred primarily within state government (-6,900 jobs). The private sector recorded a gain of 11,200 jobs in December, led by gains in Trade, Transportation & Utilities and Professional & Business Services. Prior to the pandemic (2010-2019), private sector employment averaged a gain of 9,700 jobs in December. Construction recorded a loss of 2,600 jobs, led by losses in Specialty Trades Construction Contractors and Construction of Buildings.

Employment gains were reported in the following sectors:

- Trade, Transportation & Utilities (4,500 jobs)
- Professional & Business Services (4,300 jobs)
- Education & Health Services (3,500 jobs)
- Financial Activities (3,100 jobs)
- Leisure & Hospitality (1,700 jobs)

Losses were reported in the following sectors:

- Information (-300 jobs)
- Manufacturing (-300 jobs)



Year Over Year

Arizona NSA nonfarm employment increased by 93,700 jobs or 3.1% in December year-over-year. Private sector employment increased by 91,200 jobs year-over-year, while government employment increased by 2,500 jobs year-over-year.



in thousands





Seasonally Adjusted



Year-to-Year Percent Change



Year-to-Year Percent Change



Year-to-Year Percent Change






Arizona & U.S. Retail Trade
Year-to-Year Percent Change




Arizona & U.S. Employment Services
